- Brief description of aims and methods of the study:

The main aim is to identify potential habitats of *Quercetalia pubescentis* communities in European part of Russia. Due to the lack of regional data we would like to use large-scale data from Eastern Europe.
We shall use WorldClim data and Climate Envelope Model (or Ecological Niche Model) methods to develop map of potential range of thermophilous deciduous woodlands. This will enable to collect missing field data.
